Councilwoman Crystal Wagar Resigns Due to Stiff Lobbying State Law

On December 29, 2022, former Councilwoman Crystal Wagar tendered her resignation as a Councilmember of Miami Shores Village. In her letter to the City Manager, Ms. Wagar cited FL Statute 112.3122 as the reason for not being able to serve out the remainder of her term. Her term would have ended in April 2023. In May 2022, Governor DeSantis signed the state legislature-approved law that implemented the amendment (Amendment 12) that went into effect on December 31, 2022.

Crystal Wagar who has enjoyed more than two decades of acclaimed public service and government experience in both the private and public sectors has served on the executive board of the Miami Dade County League of Cities and on the Miami Dade County Biscayne Bay Watershed Management Advisory Board. Wagar created history in 2019 when she became the first African American to be appointed Mayor since the Village's incorporation in 1932. In her 4 year term Wagar, who served during the tough COVID-19 years, has advocated for, and seen the results of, a more diverse workforce, body cams for the Police, among other welcomed changes.

In the closing line of her resignation, Wagar wrote, "It has been my honor to serve my community, serve with my esteemed colleagues and work with the incredible Miami Shores staff."

Two New Members appointed to Village Council

During the first two Village Council meetings held this past January, two new Village Councilmembers were

appointed. Timothy Crutchfield was sworn in during the first Village Council meeting on January 3rd, 2023 and Wesley Castellanos on January 17th, 2023. Councilmember Crutchfield and Councilmember Castellanos have replaced Councilwomen Katia Saint Fleur and Crystal Wagar, who both resigned in December citing a new Florida statute provision that prohibits paid lobbyists from holding public office, that law took effect on January 1st.

Councilmember Crutchfield is no stranger to Miami Shores, being a 27-year resident, attorney and former Planning and Zoning board member for the Village from 1999 to 2005.

"I will try to make sure that we maintain a healthy balance book," he spoke upon his appointment, "and that we're cautious about our financial aspects and protect the financial strength of the Village as we move forward."

Councilmember Castellanos also has history with the Village, formerly being part of the Historic Preservation Board.


"My goal will be," Castellanos said to the Council, "to make Miami Shores more beautiful than what it is now." Both councilmembers will remain in office until the end of their predecessors' terms on April 11th. 2023.

A Glimpse at Our Proposed Sustainable Initiative

Miami Shores Village recently proposed a new project called the Sustainable Miami Shores Initiative, which is geared towards laying out a blueprint of the Village's approach to implementing the sustainability and resilience goals outlined in the Strategic Management Plan. As is the case with much of South Florida, Miami Shores Village is a small compact community that sits on bedrock that is primarily comprised of limestone particles. Limestone is a highly porous sedimentary rock that easily captures and conducts water, which makes the Village highly prone to coastal and inland flooding.

As a coastal community, the Village sits in a path of vulnerability that makes it susceptible to disruptions due to hurricanes, flash floods, king tides, and sea-level rise. Some of these existing stressors and threats are projected to exacerbate overtime.



As our climate changes, temperatures increase and sea levels rise. Experts predict that storm events will intensify. As articulated in the Adopted Strategic Management Plan, efforts are underway to build upon the investments of the past, to further fortify the Village's infrastructure and create a more sustainable, climate-resilient community.

The Planning, Zoning and Resiliency Department has been tasked with spearheading the Sustainable Miami Shores Initiative by working collaboratively with the Sustainability Committee, Public Works Department, and the Neighborhood Services Department (Flood Mitigation Division). Efforts will be made to keep residents and stakeholder groups engaged on the topic of sustainability and resilience.

The Initiative would bring policies and projects such as storm water projects, Bayfront Park and seawall improvements, and land development regulations.

104th Street Project

Miami Shores Village recently introduced a resolution to improve and elevate parts of NE 104th Street. A Vulnerability Study was conducted in June 2018. The study identified the NE 104th Street corridor as a high-need area requiring flood mitigation. In November 2021, the Village was awarded a matching grant by the Florida House of Representatives, Appropriations Project Request – Fiscal Year 2022-23 House Bill #9139 in the amount of \$1,310,000. This grant was assigned to the Florida Department of Transportation (FDOT) which requires the execution of an agreement between the Village and the FDOT.

With flooding from heavy rainfall inundating the low-lying areas on NE104th Street and overwhelming the storm water system, elevating NE 104th Street can help minimize standing water depth. Also, by adding curbs and gutters, flood resilience can be enhanced, and property values protected. With the completion of the roadway improvements of this project, residents will no longer be impacted by standing water on their properties and in streets nor intrusion to their dwellings.

Comprehensive Plan EAR Update, Next Steps

The Evaluation and Appraisal Review (EAR) process is the evaluation of the **Village Comprehensive Plan** in its entirety to ensure consistency with State Law. This is an opportunity to align the Village's current and future priorities through a series of goals, objective and policies supported by adequate data and analysis.

The entire comprehensive plan includes a number of chapters called elements. As you might know, the Village already addressed two of its required elements, the Future Land Use (and associated map) and the Property Rights Elements, which are currently under review by the Department of Economic Opportunities (DEO) and external agencies. Plans are underway to begin updating the nine (9) remaining elements listed below:

How is this evaluation process done?

Staff will review the current Comprehensive Plan Goals, Objectives, and Policies (GOPs) in each element. Below is an excerpt from the existing comprehensive plan that serves as an example of a policy statement from the Capital Improvement Element:

"Objective 1: Coordinate Capital Improvements with current and future needs. In general, use the Capital Improvement Element as a means to identify capital facilities necessary to correct existing deficiencies, accommodate desired future growth and replace obsolete or worn-out facilities. In particular, the Village council will use this Element as the framework to monitor public facility needs as a basis for annual capital budget and five-year program preparation."

During the process, staff will engage the residents, businesses, property owners, Village staff and consultants to evaluate the current GOPs and explore new policies that further enhance the quality of life in the village.

January Village Council Actions

- Approved an agreement with the State of Florida Department of Transportation ("FDOT"), providing for reimbursement to the Village of an amount not to exceed \$655,000 for roadway improvements to reduce flooding and water intrusion on NE 104th street and authorizing Village officials to execute the agreement.
- Approved an agreement with the State of Florida Department of Environmental Protection ("DEP"), providing for reimbursement to the Village of an amount not to exceed \$320,000 for the design and construction of a drainage system to reduce flooding and water intrusion on NE 104th street and authorizing the Village Manager to execute the agreement.
- Approved the award of invitation to bid no. 2022-10-01 Miami Shores Police Department impact windows and doors and authorizing the Village Manager or designee to execute an agreement with the lowest responsive and responsible bidder, TechGroupOne, Inc., in an estimated amount of \$192,904.50.
- Approved the expenditure in an amount not to exceed \$2,200 from the Law Enforcement Trust Funds (LETF) to attend agracie survival tactics instructor defense tactic training by the Chesapeake Virginia Police Department.
- Authorized the Village Manager or designee to issue a purchase order to Dell Marketing, LLP for the purchase of various desktops and monitors, utilizing WSCA-NASPO contract #43211500-WSCA-15-ACS, for an amount not to exceed \$44,384.
- Approved a resolution, authorizing the execution of continuing professional services agreements with the top-ranked firms for related services in the respective nine (9) disciplines established in Request for Qualifications No. 22-06-01 "Architectural & Engineering Services Through Continuing Contracts;" and providing authorization for execution, renewal, and engagement of the qualified firms for budgeted construction, study, and consulting projects within the statutory limits established in section 287.055, Florida Statutes.

- Approved a resolution, authorizing the Village Manager or designee to execute an agreement with Chen Moore and Associates, Inc., pursuant to Request For Qualifications No. 2022-04-01 "Engineering and Architectural Design Services" for Miami Shores Village estimated amount of \$376,670.
- Approved a resolution, adopting the program for Public Information ("PPI") Document, and flood insurance coverage improvement plan and authorizing Village officials to execute and implement the necessary documents and program plans.
- Adopted an ordinance, amending the Village Comprehensive Plan by adding a property rights element, pursuant to section 163.3177(6), Florida Statutes (2023).
- Directed the Village Manager to establish a Village-wide communication plan.
- Appointed and installed Mr. Timothy Crutchfield to fill the seat vacated by Councilmember Katia Saint Fleur until April 11, 2023.
- Appointed and installed Mr. Wesley Castellanos to fill the seat vacated by Councilmember Crystal Wagar until April 11, 2023.
- Scheduled a Village Council Workshop to discuss the proposed amendments to the Village Charter on Wednesday, February 1, 2023 at the 9900 NE 2nd Avenue, beginning at 6PM.


