Councilwoman St. Fleur Resigns Ahead of Stiff Lobbying State Law

Katia St. Fleur tendered her resignation as Councilperson of Miami Shores Village ahead of the State Law establishing new constitutional standards on lobbying. St. Fleur's resignation became effective on December 15, 2022.

St. Fleur, the first Haitian American to hold office in Miami Shores Village, was elected in April 2021 for a two-year term which would have terminated in April 2023. Among her accomplishments while on the Council was her sponsorship of the Village's Strategic Management Plan – a roadmap and blueprint of priorities over the coming years.

In announcing her resignation at a special council meeting held on December 14, 2022, Ms. St. Fleur spoke about the honor and privilege she had serving her community while adding, "I sought and got legal counsel from different entities in order to be in compliance with the new state law. I am resigning because I have to."

The law which seeks to ban lobbying by ex-lawmakers will come into effect on January 1, 2023, and could bring about stiff sanctions if ex-lawmakers, including elected officials, are still in office after a December 31, 2022, deadline.

Comp Plan Adopted on first reading, now what's next?

The Village Council, as previously re-scheduled, heard the ordinance on first reading to the amendments of the Future Land Use Element and Future Land Use Map of the Village Comprehensive Plan during a Special Council meeting at the C. Lawton McCall Community Center located at 9617 Park Drive, Miami Shores on December 14, 2022 at 6:30pm. In attendance were approximately 250 residents who first heard from the facilitator, Mr. James Karas, reporting about the participatory workshop held at the Country Club on November 30, 2022. Village Staff provided a summary and chronology of the Comprehensive Plan amendments supporting data and analysis.

Village Council then discussed the item and agreed on modifications to the ordinance, for example, height for the mixed-use areas were restricted in feet instead of stories. The public hearing was open and an array of comments were echoed against and in support of the amendment. In addition to live comments, there was also an opportunity for virtual attendees to express their comments during the meeting. At this juncture, Village Council considered a motion to pass the ordinance, as amended. After the motion

was seconded, the Council voted in favor 4 to 1. This vote at first reading means the ordinance, with its supportive and required documents, will be sent to the Department of Economic Opportunities (DEO), and to the other reviewing agencies and adjacent municipalities including Miami-Dade County for comments. Besides fixing the Future Land Use Element, the Village is also required to update the 11 remaining elements. For the first time there will be a new climate change element proposed. This provides an opportunity to elevate the Village's policies and future goals pertaining to change and resilience.

The complete home hurricane inspection of any single-family home comes at no cost and no obligation to homeowners. Any homeowner who applies can receive an inspection report detailing the strength of their home against hurricanes, get recommended improvements to increase that strength, and become eligible for home improvement grants. Illegal Dumping

Illegal dumping is a problem that is having a major negative impact on Miami Shores Village's public drainage systems and our environment. Dumping materials into canals, ponds, lakes, streams or storm drains pollutes our waters and clogs up the storm drains, leading to flooding in our neighborhoods. This pollution has many adverse effects, from reducing the quality of water for drinking purposes to destroying fish and other aquatic life.

In addition to the immediate effects on local waterways, illegal dumping can also lead to long-term problems like contamination of soil and groundwater. Even if dumped material doesn't reach these areas directly, wind or rain could carry them across wider areas. This can cause a range of environmental issues such as poisoning plants and animals that rely on clean water sources for sustenance or the spread of diseases through vectors like mosquitoes.

It is important that we work together to protect our environment against this kind of damage caused by illegal dumping. We should all be aware of what happens when littering occurs; it increases the likelihood that someone else will do the same thing and continues the cycle of destruction. It is essential to report any sightings or violations to Neighborhood Services Department at (305) 762-4862 so that we may take appropriate action.

Not only does illegal dumping have an impact on the environment but it can also make living conditions worse in our community through flooding caused by blocked storm drains. This could mean that roads have to be closed off during heavy rain as well as increased health risks for those living nearby due to contaminated water entering homes or businesses. It's important for us all to do whatever we can in order to avoid this happening in Miami Shores Village by being cautious when disposing of waste and alerting authorities if anything suspicious is spotted around local waterways or storm drains.

With increased awareness of its consequences and better reporting procedures we will be able to fight this issue together and make sure that we keep our community clean, safe and healthy!

MSV Art in Public Places

Miami Shores Village Council approved an "Arts in Public Places" Ordinance created by the Miami Shores Fine Arts Commission earlier this year. This new ordinance brings definition, clarity, and purpose to the board's Art in Public Places program which began in 2009. Since its inception, Arts in Public Places has functioned at the will of the Miami Shores Fine Arts Commission, with few regulations and no guidelines for art selection or installation.

This ordinance gives way to the creation of the Arts in Public Places guidelines for submitting, commissioning and allowing art on public property throughout Miami Shores Village. The last component for the Commission is to develop an Arts in Public Places Master Plan which will identify future goals and anticipate locations throughout the Village.

Miami Shores Fine Arts Commission Chair, Susan Ackley explains, "This new ordinance is a much needed clarification of our procedures for the process of acquiring art in public space."

MSES Corner

Miami Shores Elementary School invited families to join for a Cambridge Exhibition evening at the school, where student projects across all grades were displayed. The students and families were also treated to a drawing demonstration and book signing with local author, Andrew Toffoli. Many students also signed up for their own Miami-Dade Public Library card.



MSES also held a Career Day for their students and introduced them to a variety of presenters, including but not limited to a lawyer, nurse, flight attendant, psychologist, entrepreneur, NFL scout, and street artist. Students were provided an opportunity to ask questions to further their understanding of the limitless options available to them and to enhance their communication abilities.

December Village Council Actions

- Adopted an ordinance, amending the Village zoning code to remove the percentage limitation for synthetic turf in the rear yard.
- Approved a Florida Local Agency Program agreement with the State Of Florida Department Of Transportation, providing for reimbursement to the village of an amount not to exceed \$162,000 for the construction of thirty-six ADA compliant curb ramps.
- Approved a Florida Local Agency Program agreement with The State Of Florida Department Of Transportation, providing for reimbursement to the Village of an amount not to exceed \$705,429 for construction of multimodal mobility improvements to enhance safety and mobility for pedestrians and bicyclists and construction engineering inspection services.
- Appointed Ms. Evie Isles to the Personnel Appeals Board.
- Approved the budget allocation of two full-time employees to assist with the implementation and maintenance of the Main Street Program. Appointed Seth Bramson and Jeffrey Saadeh to the Historic Preservation Board.
- Approval of the Federation of Public Employees (FPE) union contract.
- Approved the Village Manager's employment agreement terms, as amended.
- Approved an ordinance on first reading, amending the Village comprehensive plan by amending the future land use element and future land use map for properties located in Miami Shores Village.
- Directed the Village Clerk to post a vacancy announcement (with an application deadline of December 22, 2022) for a Councilmember Seat and called a Special Meeting, which will be held on December 28, 2022 at 6:30 PM, to discuss a potential appointment to such office.

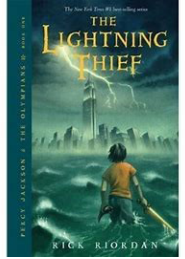

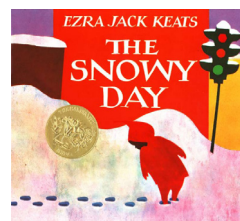

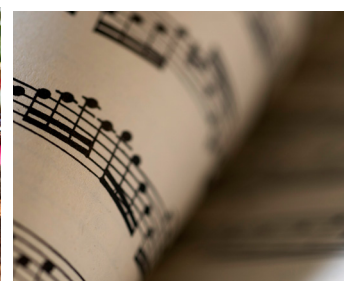

Miami Shores Village is Age-Friendly Certified by AARP

Miami Shores Village is proud to join many other South Florida municipalities as part of the AARP Network of Age-Friendly Communities. The AARP Network of Age-Friendly Communities is an affiliate of the World Health Organization's Age-Friendly Cities and Communities Program, an international effort launched in 2006 to help cities prepare for rapid population aging and the parallel trend of urbanization. The program has participating communities in more than 20 nations, as well as 10 affiliates representing more than 1,000 communities (www.aarp.org). This designation reaffirms the Village's commitment to actively work toward making Miami Shores a livable community for people of all ages.

The Village joined the AARP Network of Age-Friendly Communities and the World Health Global Network of Age-Friendly Communities in November 2018. The effort to join the network was driven by the Village Council who recognized the need to support an aging population and to create a better quality of life for older people. Over 390 communities across the United States have become age friendly communities, as well as 4 states including Florida, which joined the age-friendly network in April 2019. The Miami Shores Village Age-Friendly Action Plan was officially adopted by the Miami Shores Village Council on October 6th, 2022. This action plan provides a robust framework toward accomplishing the goals of the eight domains. By exploring them, the Village is committed to improving Miami Shores in a comprehensive way that will address all areas of livability to make significant changes in order to improve the quality of life of its residents.

The development of the Miami Shores Village Age-Friendly Action Plan, which serves to document and chart its course, provides a set of goals and related actions on which the Village will focus. There are eight key domains which include CommUNITY, Health and Participation, Housing & Participation, Transportation & Mobility, Outdoor Spaces & Buildings, Social Participation, Respect & Social Inclusion, Civic Participation & Employment and Communication & Information. These actions are in place to create an age friendly community which will help to improve the quality of lives of older adults and all residents within the community. This document provides



information on policies, services and programs that the Village currently has in place and briefly touches on some services that external organizations within the local area provide. Our goal is to seek out and establish opportunities to improve upon these services and to also find what other established organizations we may have in place to assist with these services (like the North Miami Foundation, Friendly Villagers, Woman's Club, Kiwanis) and where there may be additional needs of both elderly people and caregivers of elderly people within the community. The aim is to find out about various groups and organizations who are involved in providing services and bring them together to work to inform the community about these services and organizations.

The Village has several community policies, programs and services that are aimed at improving the quality of lives of older adults in creating an age-friendly community, social programs that provide assistance and resources to older adults, and create a safer and more walkable and transit-oriented community, and will be part of our community and comp plans. The Village wants to continue to improve the sustainability for all its residents by continuing these policies, programs, and services and working toward other initiatives and programs to continuously improve the quality of life for older residents and caregivers in the community.

We are proud the Village is now certified having created an action plan for becoming more age-friendly under the criteria established by AARP and has been renewed as a member of *The AARP Network of Age-Friendly States and Communities*.
