## Summary of Proposed Ordinance and Statement of Public Purpose to be Served

#### Purpose of the Ordinance

The purpose of this ordinance is to codify several notice practices already being utilized by staff, as well as introduce new requirements that aim to enhance public awareness and involvement in the Village's land use decision-making process. These revisions provide greater consistency, ensure compliance with state law, and improve public access to important zoning and land use information.

At its' March 27th, 2025 Planning and Zoning Board hearing, the board approved the ordinance as amended with a 3-0 vote.

#### Statement of Public Purpose

Over the past several years, the Village has reviewed multiple land use applications that generated significant public interest, particularly from residents who expressed a desire for increased transparency and more robust public notice regarding development activities. In response to this feedback and at the request of the Planning and Zoning Board, staff prepared the attached ordinance amending Article X of the zoning code to strengthen public notification procedures.
